

HEALTH INSURANCE

Do you have an insurance card that looks like this? This is called Alberta Health Care insurance.



If you have this card, you are eligible for a reduced rate at the time of renewal. What do you do?

- Print out the document called Extended Insurance Form on the last page of this document.
- Complete that form and get all required signatures.
- Submit the completed form and a copy of your Alberta Health Care insurance card (same card as in the sample above) by e-mail (<u>internationalstudents@cbe.ab.ca</u>) or in person

This card allows you to pay a reduced rate as follows:

Fee	Full Year Registration (September to June) All grades	One Semester Registration (September to January; high school only)*
Tuition	\$12,000.00	\$6,000.00
Health Insurance (combined with Alberta Health Care coverage)	\$300.00	\$150.00
Total	\$12,300.00	\$6,150.00

STUDY PERMIT RENEWAL

According to Immigration, Refugees and Citizenship Canada (IRCC):

Only some people can charge a fee or receive any other type of payment to represent or advise you on a Canadian immigration proceeding or application. These are:

- lawyers and paralegals who are members in good standing of a Canadian provincial or territorial law society,
- immigration consultants who are members in good standing of the Immigration Consultants of Canada Regulatory Council.

These people are called "authorized" representatives. IRCC will not deal with representatives who charge for their services **and** are not members of one of the above groups.

As we do receive fees from you, we cannot assist you with renewing your study permit. The same situation applies to the staff at Canada Homestay Network.

If you have strong English skills and follow the instructions very carefully, you may be able to apply directly using the online application process (http://www.cic.gc.ca/english/information/applications/extend-student.asp).

However, you may want to consider hiring a *Certified Immigration Consultant* to assist you. There is a fee for this service which you may consider to be worth paying for the peace of mind in ensuring your application is done accurately and help you avoid delays or even a rejection of your application.

REFUND POLICY

If:

Your Study Permit is denied: You will receive a full tuition refund (less a \$250 refund fee). A copy of the rejection letter must be submitted with the refund request.

- You cannot attend for other reasons: You will receive two-thirds (2/3) refund of the tuition if you withdraw prior to the commencement of the program as per the Duration of Study (program) dates on the letter of acceptance.
- You withdraw or are withdrawn from the Calgary Board of Education: Once classes have begun as per the program dates on your letter of acceptance, no refund will be given (this includes between-semester refunds). There is no refund for a midyear withdrawal.
- Late arrivals: When a student arrives late, there will be no refund for the time period missed.
- Parent's immigration status changes: If parent's immigration status changes (and meets the eligible criteria) before September 30 of the school year (September to June program) or before the end of February (February to January program), you will receive a full tuition refund (less a \$250 administration fee). If parent's immigration status changes (and meets the eligible criteria) before January 31 of the school year (September to June program) or before June 30 (February to January program), you will receive a 50% tuition refund (less a \$250 administration fee). Status changes after those deadlines will not receive a refund. Proof must be presented to Kingsland Centre (7430 5 Street S.W, telephone: 403-777-7373) prior to the last business day of specified deadline.

Families will be required to pay full year fees at the time of registration.

Tuition is refunded by the same method of payment and to the same person who originally paid.
